- viii) The inculcation of habits of living in accordance with the rich and real values of our tradition and culture.
- ix) To grant stipends, scholarships, studentship and other allowances, students and staff of the School/Institution or grantees to deserving candidates, students and staff of the School/Institution or

be facilities for giving residential accomodation for teachers, staff, students
or persons engaged in carrying out any of the objects of the Society.

to obtain money for the aims and objects of the society in the lawful manners and to
apply to deal with the same in such a manner as may be considered the most
desirable for giving effect to such aims and objects.

To do all such acts to promote, study and research.

- iii) To do all such things as are identical and conducive for attainment of the above aims
and objects or any of them.

CONDITIONS

- a) The income and property of the society shall be applied solely towards the promotion
of the objects of the society as set forth in the Memorandum of Association and no
portion thereof shall be paid or transferred directly or indirectly or indirectly, to the
members of the Society.
- b) No member of the society, shall be appointed to any salaried office of the Society, or
any office of the Society paid by fees, that no remuneration shall be given by the
society to any member of the society except repayment of out of pocket expenses
and interest on money lent or rent for premises/demised to the Society.
- c) The Society by its constitution is required to apply its profits, if any, or other income in
promoting its objects.
- d) If upon the winding up or dissolution of the society there remain after satisfaction of
all debts and Liabilities any property whatever, the same shall not be paid to be or
distributed among the member of the society, but shall be given or transferred to
some other institution having objects similar to the objects of the society to be
determined at or before the time of dissolution.
- e) That society will solve their problems or disputes on their level and Registrar
Firm & Society will be no involvement in that case.
